

Operating an early childhood center during a pandemic has certainly been an interesting experience! While the halls of the school continued to be filled with laughter, friendship and learning, there was also a pervasive feeling of fear and anxiety. From one day to the next, we did not know which classroom would be quarantined and who would be in isolation due to a positive COVID-19 test. There was a certain level of exhaustion that came from holding so many feelings.

Thanks to our generous community, public support donations increased dramatically. Our community knows the value of a Bal Swan experience and they demonstrated that belief through their generosity. The Paycheck Protection Program support from the federal government also helped and was turned into grant funds in the 2021 fiscal year. Additionally, many state and local foundations helped by supplying personal protective equipment. The Bal Swan workforce stayed stable and provided the stability and love their students need and deserve.




CHART REVENUE/EXPENSES FROM-JULY 2020 TO JUNE 2021

The above graph illustrates how Bal Swan survived fiscally through the pandemic. Whereas tuition in prior years contributed to 60-65% of overall revenues, FY2021 tuition revenue decreased to 45% of overall revenues. Increased grant funds from years past are from the conversion of the paycheck protection program loan being converted to a grant.

One commitment Bal Swan made during this cycle was to providing an educational home for as many children with disabilities as possible. We increased the number of children with disabilities to remain true to our model of inclusion and to provide a safe place for children to learn and grow during the pandemic. It was gratifying to see the growth in these young children at a time when so many children were isolated. Therapy support for all children ensured that children did not incur any pandemic setbacks in their development. Many of the therapy support came at no cost to parents.

Resilience in Learning

Children are the most amazing example of resilience! Despite masks and more socially distanced play at school, children demonstrated their desire to be a part of a community, to have friends, to learn together and to prioritize human relationships. Teachers and therapists taught reading body and facial cues without seeing a person's mouth, and children continued to develop their emotional vocabulary and empathy. They cued in on voice tone, on eye movement and on body language and their development was not compromised. Bal Swan students also received the therapy support they needed to achieve their developmental milestones.





Importance of Community

Bal Swan has been a community entity since its inception, and the pandemic humbly reminded us what a cherished non-profit we are in the community. When funds from tuition decreased, the community dug into their pocketbooks to help Bal Swan sustain its operation and continue providing child-focused, holistic services to our community. Dreaming About Bal Swan's Future

During the 2021 fiscal year, Bal Swan's Board hired Adolfson & Peterson Construction to create a Master Plan for a potential new building. The impetus for this decision was a Board vote the previous year to invest in three areas for Bal Swan's future:

expansion of therapy services expansion of programming modernization of the building

After exploring many options, Bal Swan decided to stay on its existing property and see if expansion could occur on the current footprint without any additional land acquisition. The Master Plan designed by Hord, Coplan & Macht (HCM) is below. We are still collecting community input on whether expansion to the younger or older areas (or both) will benefit our community the most. Please complete the survey to share your feedback with us.
